## Antigravity Batteries Policies for 3rd Party Resellers (Amazon, Ebay, Walmart, etc.)

- No selling of Antigravity products on Amazon or other 3rd Party (3P) Selling sites without Antigravity Batteries written Permission. We have instituted an Application Process to sell Antigravity Batteries products on Amazon, etc. Any resellers who desire to sell our products on 3P sites must complete an Application and submit it for written approval. The 3rd Party Seller Application is available here: https://antigravitybatteries.com/reseller-resources/ This Application only applies if you sell on 3rd Party sites; you can freely sell our product on your own website adhering to our MAP Policy, or brick and mortar stores as always.
- 2. No Dealers/Distributors or other Resellers aside from Antigravity Batteries, will be authorized to use Amazon's "Fulfilled by Amazon" (FBA) Market or Vendor Central Market.
- No Resellers will be allowed who do not own a legitimate Motorsports related Business. A Business Name, Address and Phone will be required in your Amazon/3P Account to handle Customer Service. We will not accept residential addresses, PO Boxes or non verified addresses.
- 4. No Resellers with different Amazon Company Names that do not reflect their official Business Name will be accepted. Sellers using different Amazon Seller Names than their actual Business Name, or buying products and reselling on Amazon under a different name will not be allowed to sell Antigravity Batteries Products on any 3P platforms.
- 5. Resellers must list accurate and complete Contact Information on any 3rd Party Selling Platform.
- 6. Antigravity Batteries Product on Amazon will be limited to certain products. Resellers may list only the products we have allowed for sale on Amazon and other sites.
- 7. No Resellers will be allowed to sell Antigravity Products other than RE-START Motorcycle/Powersport Batteries and some models of its Jump Starters. Sales of other products will not be allowed.
- 8. NO USED PRODUCTS can be sold by any Reseller of Antigravity Batteries online whatsoever. If any product is sold used, the Customer must be notified in writing that there will be no warranty or support from Antigravity Batteries. Warranties as stated in our official warranty are only for the original purchaser. No transfers or resales of used products.
- 9. No Resellers will be permitted, who do not maintain a good Seller Ranking. All Resellers must address Customer issues regarding our products and either take action or inform us of the issue. Bad reviews/complaints due to shipping, or other issues within the control of the Seller will not be acceptable.
- 10. Any company found to be creating new Amazon listings of our products or attempting to alter listings of Antigravity Batteries Products will be banned from selling Antigravity Products. Only Antigravity Batteries will be allowed to create, update, or change listings on Amazon.
- 11. Resellers who do not follow our Policies will be subject to a first warning and given 48 hours to correct. If they do not correct within this time, they will be put on a "no sales list" at our Distributors, and within Antigravity Batteries for 4 months. If a second breach of our Policies occurs, they will be banned from selling Antigravity Batteries products for a year.
- 12. Antigravity reserves the right to reject or deny any application for any reason it deems appropriate.
